**List of Candidates shortlisted for Additional Document Verification (ADV-6) (Pay Level-2)**

- 1.0: Candidates bearing the Roll Numbers listed herein under have been provisionally shortlisted for the Additional Document Verification (ADV-6) for the posts notified in Pay Level –2, based on their score in 2nd stage CBT, and the priority for various posts furnished by them in the online application. This list of shortlisted candidates for ADV-6 is drawn equal to the revised vacancies published in the websites of RRBs, subject to availability of eligible candidates.
- 2.0: The Additional Document Verification (ADV-6) will start on 21.12.2023 and Block date for absent candidates is on 27.12.2023. With the publishing of this result on official website it shall be treated as communication regarding document verification stands completed. However, in addition to this an e-mail will also be sent to candidates to download their e-call letter in case due to any technical error if e-mail is not received even though the candidates should attend document verification as per schedule given in this result.
- 3.0: Candidates may note that after successful completion of ADV-6, they have to undergo Initial Medical Examination at the nominated Railway Hospitals located in the jurisdiction of RRB. The candidates are required to come prepared to stay for three to four days. Candidates have to pay the prescribed medical fee of Rs.24/-. Accordingly, candidates have to come prepared for ADV-6 and medical examination. No second chance for initial medical examination will be given if the candidate remain absent on the scheduled date for the medical examination.
- 4.0: The shortlisted candidates for ADV-6 should produce all the original documents along with one set of Xerox copies in A4 size as detailed in the CEN and e-call letter.
- 5.0: Candidature of all the shortlisted candidates for Additional Document Verification (ADV-6) is purely provisional and is liable to be cancelled, at any stage of recruitment or thereafter, in case of any inconsistency / deficiency in the data furnished by them in their online application or any malpractice on the part of candidates coming to the notice of RRB at any stage of the recruitment process. It may be noted that merely calling a candidate for Additional Document Verification (ADV-6) does not entitle him/her in any way to an appointment in the Railways.
- 6.0: While every care has been taken in preparing the list of candidates shortlisted for Additional Document Verification (ADV-6), RRB reserves the right to rectify any inadvertent error or typographical/printing mistakes. RRB regrets for the inability to entertain any correspondence from unsuccessful candidates.
- 7.0: Important: Beware of the touts who may misguide the candidates with false promises of getting them selected for the job on illegal consideration. The recruitment process in the RRB exams is fully computerised and the selection is based purely on the merit of the candidates.
- 8.0: Candidates are advised to regularly visit RRB's official website for the updates.
- 9.0: The Roll Numbers of provisionally shortlisted candidates for Additional Document Verification (ADV-6) which is fixed on 21.12.2023, are arranged in ascending order and not in the order of merit.
